Carry On Caring



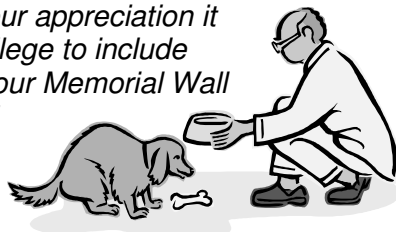
Spare a thought for tomorrow's animals. What happens after you have gone?

The problems of cruelty and neglect among animals won't have gone but there will always be caring people to carry on the work of the uMngeni SPCA but the costs of such care will inevitably keep escalating.

HOW DO I MAKE PROVISION FOR ANIMAL WELFARE IN MY WILL?

1. If you don't already have a Will then contact your solicitor, financial advisor or bank for assistance. Ensure that your wishes regarding a bequest for animal welfare is incorporated in the document.
2. If you already have a Will then you can simply add a codicil to be attached to your Will.
3. You may choose to bequeath a set sum of money for animals but since the value of money erodes so quickly we would like to suggest that you should consider other options such as allocating a percentage of your estate or even the residue of your estate after all other beneficiaries have been accommodated.
4. Do please give our appeal your kind consideration - just a small percentage could be a lifeline for animals in distress in the future. If you wish to leave money to this SPCA it is important that "uMngeni SPCA" is clearly specified.
5. Feel free to use the Codicil Form adjoining. Select one of the options in Section 2 and cross out and initial the rest. Sign, in front of two witnesses, and then ensure that this Codicil is attached to your Last Will and Testament.
6. That's all there is to it!

As a token of our appreciation it will be our privilege to include your name on our Memorial Wall at the uMngeni SPCA.



CODICIL TO THE LAST WILL AND TESTAMENT OF

1. This is a codicil to the Last Will and Testament of me,
residing at and dated 20.....
 2. I leave as a legacy to the UMNGENI SPCA the sum of R.....
 or alternatively:-
 - 2a) I leave as a legacy to the UMNGENI SPCA a sum equal to% of the net value of my estate (and for these purposes the net value of my estate shall mean the total value of my estate less all liabilities in existence at the date of my death).
 or alternatively:-
 - 2b) I leave as a legacy to the UMNGENI SPCA the sum of R..... or a sum equal to% of the net value of my estate (and for these purposes the net value of my estate shall mean the total value of my estate less all liabilities in existence at the date of my death) whichever is the greater.
 or alternatively:-
 - 2c) I leave as a legacy to the UMNGENI SPCA the residue of my estate after all other aspects of my Will are settled.
 3. Save as aforesaid, my said Will remains unaltered and of full force and effect.
 4. THUS DONE and EXECUTED at on this Day
 of in the year two thousand and (2.....), in the presence of the subscribed witnesses who, in the presence of each other and in my presence all being present at the same time having duly signed this Codicil.
